Our district uses The Michigan Integrated Continuous Improvement Process (MICIP) which looks at the whole child and how to meet the needs of each child looking at the emotional, physical, and social needs of our student as well as their academic needs. In addition a new research based math program has been purchased, professional development provided and the program implemented at the beginning of the year.
